## BEFORE THE WASHINGTON UTILITIES AND TRANSPORTATION COMMISSION

In the Matter of Penalty Assessment Against Jorge Humberto Luna-Lopez d/b/a UR Moving Solutions in the Amount of \$3,100 **DOCKET TV-091621** 

DECLARATION OF SHERI HOYT

SHERI HOYT, under penalty of perjury under the laws of the state of Washington, declares as follows:

- 1. I am over 18 years of age, a citizen of the United States, a resident of the state of Washington, and competent to be a witness.
- 2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Compliance Investigations Section. I have been employed at the Commission for over 17 years, holding various positions. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility or transportation companies. As part of those duties, I investigate household goods carriers that may be operating in violation of Commission statute, rule, or tariff.
- 3. On October 26, 2009, Jorge Humberto Luna-Lopez d/b/a UR Moving Solutions (UR Moving Solutions) filed with the Commission an Application for Mitigation (Mitigation Request), in Docket TV-091621. I have read the Mitigation Request. In the Mitigation Request, UR Moving Solutions waives a hearing and asks for an administrative decision.
- 4. This Mitigation Request arises from a Notice of Penalties Incurred and Due for Violations of Laws and Rules issued by the Commission on October 19, 2009, in Docket TV-091621. In that Notice, the Commission issued a penalty of \$3,100 for 32 violations of Washington Administrative Code 480-15-610, which requires household goods carriers include the Commission-issued permit number, name or trade name as recorded at the Commission, business address and business telephone number in any advertising for household goods moving services. In addition, carriers may not advertise services or rates and charges that conflict with the tariff.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup>In preparing its Response to the Company's Application Mitigation, Staff discovered a mathematical discrepancy. The Penalty Assessment, and Staff's investigation report, detail 32 violations of WAC 480-15-610. However, the investigation report incorrectly calculates that the detailed violations total 31. Based on that incorrect figure, Staff recommended a \$3,100 penalty (\$100 per violation), and the Commission subsequently issued a \$3,100 penalty assessment. Because of its error and the timing of its discovery, Staff does not seek to amend its investigation report recommendation, or the subsequent penalty assessment.

5. Before recommending the Commission issue penalties, as part of my job, I conducted an investigation of Commission records concerning UR Moving Solutions. I documented my investigation in a report titled, "Jorge Humberto Luna-Lopez d/b/a UR Moving Solutions - Staff Investigation"<sup>2</sup>. I identified the violations in this case from fifteen advertisements placed by UR Moving Solutions.

## Specific Issues Addressed by UR Moving Solutions in its Mitigation Request

UR Moving Solutions states it made correcting its advertising violations a top priority after receiving the penalty assessment order and that it would do its utmost to comply with the rules of the Commission and that it welcomes staff's help in doing so. Further, UR Moving Solutions stated the advertisements were never meant to defraud or mislead anyone or to misrepresent its services to the public. UR Moving Solutions asks the Administrative Law Judge to forgive its errors, review its immediate corrections, and says it is thankful for any considerations given under the circumstances.

- 6. In the Mitigation Request, UR Moving Solutions states it made making the necessary corrections to its advertisements a top priority.
- 7. The company owner, Jorge Luna-Lopez, came to the Commission to speak with me the day after he received the penalty order in the mail. Mr. Luna-Lopez indicated to me that all Craigslist advertisements had already been corrected and the advertisement posted on backpage.com had been deleted entirely.
- 8. In the Mitigation Request, the company also included copies of its Craigslist advertisements with its Mitigation Request to demonstrate it had made all the changes necessary and that all required elements are now present in its advertisements. A review of the advertisement copies provided by UR Moving Solutions revealed all violations had been corrected. A review of an additional 10 advertisements posted to Craigslist between November 2, 2009, and November 5, 2009, revealed all violations have been corrected.
- 9. During my October 21, 2009, meeting with Mr. Luna-Lopez here at the Commission, we spoke at length about the rules and tariff requirements for household goods carriers. During the meeting I realized that, although Mr. Luna-Lopez has attended two training sessions and has been provided written technical assistance, and I believe he strives to understand the rules and tariff and follow them, he best understands the rules and tariff when explanations are provided in the form of examples or scenarios.
- 10. UR Moving Solutions was penalized for five violations of WAC 480-15-610(4) as five advertisements indicated the company had no minimum hours. Tariff 15-C,

Item 230, requires, for services provided at the customer's request, a minimum of one hour, Monday through Friday, excluding state-recognized holidays, between 8:00 a.m. and 5:00 p.m. and a minimum of four hours on Monday through Friday, before 8:00 a.m. and after 5:00 p.m. or on a Saturday, Sunday or state-recognized holiday. At his request, I explained to Mr. Luna-Lopez when we met that he is not required to post the minimum hour charge in his advertisements, however, if he does, it must be in compliance with the tariff. Mr. Luna-Lopez and I discussed these requirements in several scenarios and I feel he now has a clear understanding of the tariff requirement and what his advertisements must contain. A review of UR Moving Solutions' currently posted Craigslist advertisements<sup>3</sup> revealed the company no longer has a minimum hour designation posted.

11. UR Moving Solutions was penalized for eleven violations of WAC 480-15-610(1) for failing to include its company name, for fifteen violations of WAC 480-15-610(1) for failing to include its business address, and one violation of WAC 480-15-610(1) for failing to include its Commission-issued permit number in the advertisements that were the basis for the penalty assessment. My review of the advertisements currently posted to Craigslist as of the date of this declaration revealed that the company's name, business address and permit number are all present.

## **Staff Recommendation**

- 12. Staff believes that UR Moving Solutions took steps to immediately correct the violations once it received the penalty assessment. Although the company had previously received training and technical assistance in the form of a compliance letter, staff believes that the errors were inadvertent and that the company, as it has stated, did not intend the advertisements to defraud or mislead anyone or to misrepresent its services to the public. Staff believes that this carrier perhaps needed technical assistance in a more specialized manner, such as has been provided in examples and scenarios at the company's request.
- 13. Staff believes that a penalty assessment is used as a tool to enforce future compliance. As the company has now complied and staff believes it will continue to do so going forward, staff recommends that the company be given substantial mitigation of the penalty assessment. Staff recommends that the company pay \$100 per each required element that was omitted from the advertisements, for a total of \$400, as follows:, \$100 for the lack of its company name appearing in the advertisements, \$100 for the lack of its business address appearing in the advertisements, \$100 for the lack of its Commission-issued permit number appearing in the advertisements and \$100 for the misrepresentation on minimum hours to be charged.

14.	If the Commission does not accept Staff's recommendation to mitigate the penalty
	as detailed above, Staff,, in the alternative, is not opposed to UR Moving
	Solutions being allowed to make equal monthly payments for a period of one year
	for the penalty assessment amount.

## Appendix A

## Jorge Humberto Luna-Lopez d/b/a UR Moving Solutions

Staff Investigation October 14, 2009

## Purpose

The purpose of this investigation is to determine if Jorge Humberto Luna-Lopez d/b/a UR Moving Solutions is in violation of Washington Administrative Code (WAC) 480-15-610. WAC 480-15-610 requires household goods carriers to include the commission-issued permit number, name or trade name as recorded at the commission, business address and business telephone number in any advertising for household goods moving services. In addition, carriers may not advertise services or rates and charges that conflict with those in the Household Goods Tariff 15-C.

This investigation was prompted by a complaint received by the commission on October 5, 2009, from a permitted household goods carrier. The carrier provided documents regarding non-permitted household goods carriers advertising on the goods and services Web site, <a href="https://www.craigslist.org">www.craigslist.org</a>, as well as violations contained in advertisements posted by permitted carriers. An advertisement posted on September 29, 2009, was included in the documents provided by the complainant.

## Background

On November 14, 2008, the commission granted Jorge Humberto Luna-Lopez d/b/a Luna's Moving Services provisional household goods authority and issued the company permit number THG-63429. On August 27, 2009, Mr. Luna-Lopez requested his trade name be changed to UR Moving Solutions. The name change was granted effective September 29, 2009.

## Investigation

On January 28, 2009, the commission sent Mr. Luna-Lopez a compliance letter<sup>1</sup> regarding violations of WAC 480-15-610 in an advertisement posted on January 21, 2009, to Craigslist. The advertisement failed to include Mr. Luna-Lopez's company name, business address and the commission-issued permit number. In addition, the advertisement indicated the company had a three hour minimum, a violation of Tariff 15-C, Item 230, Hourly Rates.

Tariff 15-C, Item 230, allows for a minimum charge of one hour for services provided at the customer's request, Monday through Friday, excluding state-recognized holidays, between 8:00 a.m. and 5:00 p.m. and a minimum charge of four hours on Monday through Friday, before 8:00 a.m. and after 5:00 p.m., or on a Saturday, Sunday or state-recognized holiday.

Mr. Luna-Lopez was required to respond to the compliance letter by February 9, 2009, confirming that he had corrected all advertisements and listings to include his company's name as it appeared on his permit, to include his business address and his commission-issued permit

number. Mr. Luna-Lopez was also to confirm that he had corrected all advertisements and listings to be in compliance with Tariff 15-C regarding hourly rates.

On February 6, 2009, Mr. Luna-Lopez came to the commission to discuss with me the compliance letter he received and the changes he needed to make. I followed up the in-person meeting with two e-mails to Mr. Luna-Lopez, one on February 6, 2009, and the other on February 9, 2009, recapping what we had discussed and providing him further information at his request.

On November 4, 2008, Mr. Luna-Lopez attended the mandatory new entrant household goods training. At his request, made on February 6, 2009, Mr. Luna-Lopez attended a second training session held on February 12, 2009. For both training sessions Mr. Luna-Lopez initialed an Attendee Verification form acknowledging he received training for, among other things, advertising and rates for hourly-rated moves.

On August 7, 2009, while researching non-permitted household goods company advertisements on Craigslist, I found an advertisement posted that morning at 10:37 for Mr. Luna-Lopez's company. The advertisement did include the company's commission-issued permit number, however, it lacked the company's name or business address.

On October 5, 2009, the commission received a complaint from a permitted household goods carrier regarding non-permitted household goods carriers advertising on Craigslist as well as violations contained in advertisements posted by permitted carriers. Mr. Luna-Lopez's September 29, 2009, advertisement was included in the documents provided by the complainant.

A search of Craigslist revealed 14 advertisements for Mr. Luna-Lopez's company posted between September 28, 2009, and October 5, 2009. An internet search revealed one additional advertisement posted on <a href="https://www.backpage.com">www.backpage.com</a> on September 24, 2009. All advertisements contained violations of WAC 480-15-610<sup>2</sup>. A review of the advertisement revealed a total of 31 violations. They are as follows:

- Craigslist, posted September 28, 2009, at 6:36 a.m. missing the company name and business address and the advertisement states there is no minimum "for most moving jobs;" three violations.
- Craigslist, posted September 28, 2009, at 4:23 p.m. missing the business address; one violation.
- Craigslist, posted September 29, 2009, at 8:41 a.m. missing the company name and business address; two violations.
- Craigslist, posted September 29, 2009, at 3:01 p.m. missing the company name, business address and commission-issued permit number; three violations.
- Craigslist, posted September 30, 2009, at 8:19 a.m. missing the company name, business address, and the advertisement states there is no minimum for "most moving jobs" ... "M-F from 8:00 am to 5:00 pm"; three violations.

- Craigslist, posted September 30, 2009, at 9:22 p.m. missing the company name and business address; two violations.
- Craigslist, posted October 1, 2009, at 8:22 a.m. missing the company name and business address; two violations.
- Craigslist, posted October 1, 2009, at 3:42 p.m. missing the company name and business address; two violations.
- Craigslist, posted October 2, 2009, at 4:47 p.m. missing the company name and business address; two violations.
- Craigslist, posted October 3, 2009, at 1:27 p.m. missing the company name, business address, and the advertisement states there is "no minimum of hours for most moving jobs;" three violations.
- Craigslist, posted October 3, 2009, at 4:23 p.m. missing the company name, business address, and the advertisement states "we do not have a minimum of hours Mon-Fri from 8:00 am to 5:00 pm;" three violations.
- Craigslist, posted October 4, 2009, at 9:20 p.m. missing the company business address; one violation.
- Craigslist, posted October 4, 2009, at 9:26 p.m. missing the company business address; one violation.
- Craigslist, posted October 5, 2009, at 7:57 a.m. missing the company business address; one violation.
- Backpage.com, posted September 24, 2009 missing the company name, business address and the advertisement states "THERE IS NO MINIMUM OF HOURS M-F 8:00 am to 5:00 pm;" three violations.

## Recommendation

Penalize Jorge Humbert Luna-Lopez d/b/a UR Moving Solutions, \$3,100 for 31 violations of Washington Administrative Code 480-15-610, Advertising. Mr. Luna-Lopez was provided technical assistance through a compliance letter, direct contact with staff and two training sessions presented by the commission and continues to have violations in his advertisements.

Re: Advertising

Dear Mr. Luna-Lopez:

On November 25, 2008, the Utilities and Transportation Commission (commission) granted you temporary household goods authority under permit THG-63429. As of that date, you are allowed to provide intrastate household goods moving services on a provisional basis.

On January 21, 2009, commission staff found an advertisement for your company (enclosed) posted that same day on the goods and services Web site, <a href="www.craigslist.org">www.craigslist.org</a>. The rules addressing advertising by a household goods moving company are contained in Washington Administrative Code (WAC) 480-15-610 (enclosed).

WAC 480-15-610 requires your name or trade name as recorded at the commission, along with specific information, be included in all advertisements for household goods moving services. Your Craigslist advertisement fails to include your company name and is lacking the required commission-issued permit number and your business address.

In addition, in your Craigslist advertisement, you state you have a three (3) hour minimum. **Please note this is a violation of the commission's Tariff 15-C, Item 230, Hourly Rates.** In accordance with Item 230, the minimum charge for a shipment moving under hourly rates is one hour. The exclusion is a four (4) hour minimum for services provided at the <u>customer's</u> request Monday through Friday, before 8:00 a.m. and after 6:00 p.m., or on a Saturday, Sunday or state-recognized holiday.

In addition, the advertisement states your rates to be: \$75/Hr for 2 guys labor/truck/equipment \$99/Hr 3 guys labor/truck/equipment Jorge Humberto Luna-Lupez d/b/a Luna's Moving Services January 28, 2009 Page 2

Your advertisement does not state whether the rates offered are for moves with an expected duration of three hours or less or more than a three hour duration, but do not appear to be in compliance with the tariff. You also state there is a five percent discount with a cash payment. In accordance with Tariff 15-C, Item 230, section six (6), you may only charge local (hourly-rated) moves at the following rates:

- a. Charge for truck and driver:
  - For a move three (3) hours or less in duration, a minimum of \$39.2 per hour and a maximum of \$81.68 per hour.
  - ii. For a move more than three (3) hours in duration, a minimum of \$37.93 per hour and a maximum of \$79.04 per hour.
- b. Additional charge for each additional worker:
  - For a move three (3) hours or less in duration, a minimum of \$30.69 per hour and a maximum of \$61.74 per hour.

An hourly rate minimum and maximum examples chart is enclosed for your review. The example chart was prepared by Penny Ingram in the commission's Regulatory Services Division. Should you have questions regarding the chart or rates to be charged, you may contact Ms. Ingram at (360) 664-1242 or pingram@utc.wa.gov for further information.

## You must respond to us in writing by February 9, 2009, regarding the following issues:

- Please confirm that you corrected all advertisements and listings to include your company's name as it appears on your permit (Luna's Moving Services) along with your business address and UTC permit number (HG-63429).
- Please confirm that you have corrected all advertisements and listings to be in compliance with Tariff 15-C regarding hourly rates.

Please note that the commission considers this letter to be technical assistance for you. Any future violations identified by commission staff of these same rules or tariff items addressed here will be subject to enforcement actions, which may include financial penalties.

## WAC 480-15-610 Advertising.

- (1) Carriers must include the commission-issued permit number, name or trade name as recorded at the commission, business address and business telephone number in any advertising for household goods moving services. Advertising includes, but is not limited to:
- (a) Advertisements in telephone books, newspapers, correspondence, cards, or any other written document.
  - (b) Signs, posters or similar displays.
  - (c) Web sites or other on-line advertising.
  - (2) Advertisements may not be misleading, false or deceptive.
- (3) Carriers may advertise services provided as an agent of, or connecting carrier to, another household goods carrier if they include the name and permit number of the other household goods carrier in their advertising.
  - (4) Carriers may not advertise services or rates and charges that conflict with those in the tariff.
