BACKGROUND

1 On August 7, 2013, the Washington Utilities and Transportation Commission (Commission) assessed a penalty in the amount of \$1,800 against Pierre Maggitt (Company), for violations of WAC 480-15-480. This rule requires household goods carriers to file annual reports with the Commission by May 1 each year.

2 On January 30, 2014, Commission Staff (Staff) contacted the Executive Director and Secretary of the Commission explaining that Pierre Maggitt had requested to pay the assessed penalty in installments, and that Staff supported the request. Pierre Maggitt and Staff proposed the following payment schedule:

February 15, 2014	\$360
March 15, 2014	\$360
April 15, 2014	\$360
May 15, 2014	\$360
June 15, 2014	\$360

3 Staff also proposes that if Pierre Maggitt fails to pay the entire \$1,800 penalty by 5:00 p.m. on June 15, 2014, the Commission may cancel Pierre Maggitt’s household goods carrier permit.

DISCUSSION

- 4 The installment payment schedule Staff and the Company propose is reasonable. The Commission approves that proposal with two modifications. First, the installment date for February, March and June are extended so that the due dates land on a business day rather than a weekend. Second, Pierre Maggitt may pay in installments only if the Company pays each installment when it is due. If Pierre Maggitt fails to timely pay one installment, the entirety of the remaining balance of the assessed penalty will become immediately due and payable, and the Commission may cancel the Company's household goods permit.

ORDER

THE COMMISSION ORDERS THAT:

- 5 (1) The penalty of \$1,800 is due and payable to the Commission in installments as follows:

- 6 (2) If Pierre Maggitt fails to pay any installment by 5:00 p.m. on the date that installment payment is due, the unpaid balance will immediately become due and payable without further order by the Commission.
- 7 (3) If Pierre Maggitt fails to pay any portion of the assessed penalty, the Commission may cancel the Company's household goods carrier permit by order in this docket.

- 8 The Secretary has been delegated authority to enter this order on behalf of the Commissioners under WAC 480-07-904(1)(h).
