- On June 9, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TG-141168 against Ludtke – Pacific Trucking, Inc. in the amount of \$1,000, alleging a violation of WAC 480-70-071, which requires permitted solid waste companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- 2 On June 20, 2014, Ludtke Pacific Trucking, Inc. filed with the Commission a request for hearing stating that their long time in house accountant had become ill. It wasn't until she was no longer with the company that they discovered she had missed many deadlines.
- ³ Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-70-071 occurred and, if so, whether the penalty should be mitigated.
- 4 THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m., on Tuesday, August 26, 2014, in Room 206, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
- 5 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
