## CLAIM OF CONFIDENTIALY

Under covering letter, dated July 30, 2014, Pioneer Telephone Company (“Company”) filed with the Washington Utilities and Transportation Commission (“Commission”) the Company’s petition, pursuant to WAC 480-123-100 and -110, to receive support from the state Universal Communications Services Program (“Petition”). Since then, it has been discovered that the first paragraph on page 3 of the confidential (unredacted) version of Exhibit 5 to the Petition and the first two paragraphs on page 12 of the confidential (unredacted) version of that exhibit each contained an incorrect reference to “PIONEER TELEPHONE COMPANY, Inc.” These references should have been to “Pioneer Telephone Holding Company, Inc.” and “PIONEER TELEPHONE HOLDING COMPANY, INC.,” respectively. The errors were introduced inadvertently by the manner in which the footer was added to the document for purposes of the above-mentioned filing and did not affect the redacted version of Exhibit 5.

Consequently, accompanying this letter are (i) an original of an unredacted replacement page 3 of Exhibit 5 and (ii) an original of a confidential (unredacted)
