Section 18.1 <u>Limitation of Liability</u>. No Member or manager shall be personally liable to the Company or the other Members for damages resulting from that Member's or manager's conduct as a Member or manager. This liability exclusion shall not apply, however, to: (1) intentional misconduct; (2) a knowing violation of law; (3) a distribution violating RCW 25.15.235; or (4) any transaction from which the Member or manager will personally receive a benefit in money, property, or services to which the Member or manager is not legally entitled.

Section 18.2 <u>Indemnity</u>. The Company shall indemnify any Member or manager from and against any judgments, settlements, penalties, fines, or expenses, including reasonable attorney's fees, incurred in a proceeding to which an individual is a party because he or she is, or was, a Member or a manager. This duty to indemnify shall not extend to any conduct or omission that is finally adjudged to be: (1) intentional misconduct; (2) a knowing violation of law; (3) a distribution violating RCW 25.15.235; or (4) a transaction from which the Member or manager personally received a benefit in money, or services to which the Member or manager is not legally entitled.
