ORDER RESCINDING GRADE  
CROSSING PROTECTIVE FUND  
GRANT

**BACKGROUND**

- 1 On September 20, 2016, the Washington Utilities and Transportation Commission (Commission) entered an order granting a petition by Grant County Public Works (Grant County) for a disbursement from the Grade Crossing Protective Fund (GCPF) totaling \$20,000. The grant was to provide partial funding for a project related to modifying the active warning devices at a railroad-highway grade crossing, identified as USDOT 065792C, located at Adams Road in Grant county.
- 2 On May 4, 2017, Grant County submitted an email requesting to withdraw its petition for GCPF funds because the crossing upgrades cannot be completed by the June 15, 2017, deadline.

**FINDINGS AND CONCLUSIONS**

- 3 (1) On September 20, 2016, the Commission approved a petition by Grant County for a Grade Crossing Protective Fund disbursement of \$20,000. The disbursement was approved after considering the relative priorities of all funding applications pending at the time.
- 4 (2) The Commission's approval of the petition included a condition that the funds be used by June 15, 2017.
- 5 (3) On May 4, 2017, Grant County, having determined that the project could not be completed by the required date, filed an email requesting to withdraw its petition for grant funds.

**ORDER**

THE COMMISSION ORDERS:

- 6 (1) The Grade Crossing Protective Fund grant awarded to Grant County Public Services is rescinded, thereby returning the amount of \$20,000 to the Grade Crossing Protective Fund account for further disbursement consideration.

The Secretary of the Commission has delegated authority over this matter pursuant to Order 01 in Docket A-151775. The Secretary finds this Order to be consistent with the public interest.
