1 p.m.)**

- 1 On August 9, 2017, Beeline Tours Ltd d/b/a Seattle Express (Beeline or Complainant) filed with the Washington Utilities and Transportation Commission (Commission) a formal complaint against Bhupinder Singh Brar d/b/a Brar Airport Towncar Service (Brar Towncar or Respondent), alleging violations of RCW 81.68.020 and RCW 81.68.040.
- 2 On August 31, 2017, Brar Towncar submitted a letter to the Commission denying the allegations.
- 3 Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for resolving the issues in this matter.
- 4 **THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 1 p.m., on Thursday, November 2, 2017, in Room 206, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**
- 5 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
- 6 Written notice of any other stage in the proceeding or other formal proceedings that the Commission may deem appropriate will be given during the course of this case. The Commission will provide at its offices in Olympia, Washington, copies of

documents in the current record for use by the parties or others who may want to review them.

7 The Commission requests that the parties bring the following documents for consideration at the brief adjudicative proceeding:

**Beeline:** Any and all documents supporting the allegations in the complaint.

**Brar Towncar:** Any and all trip reports, invoices, schedules, statements, and documents relating to trips between the Red Roof Inn Seattle Airport, located at 16838 International Blvd., SeaTac, Washington, and Cruise Terminals #66 and #91.

The Commission also requests that parties file a list enumerating and describing any such documents **no later than 5:00 p.m. on Thursday, October 27**, and bring an original and three (3) copies to the hearing. Filing shall be in accordance with WAC 480-07-140(5).

8 **THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.**
