On January 19, 2018, SEATAC SHUTTLE, LLC, d/b/a WHIDBEY SEATAC SHUTTLE, (SeaTac Shuttle), filed an application with the Washington Utilities and Transportation Commission (Commission) in accordance with RCW 81.68 requesting extension of service under passenger transportation company certificate C001077 to provide the following service:

SCHEDULED PASSENGER SERVICE by reservation only:

AIRPORTER PASSENGER SERVICE BETWEEN: Whidbey Island and Paine Field Airport.

CLOSED DOOR SERVICE BETWEEN: Deception Pass and Paine Field and BETWEEN the Clinton Ferry and Paine Field.

The application appeared on the January 26, 2018 application docket. The application was unopposed.

- In support of the request to extend its authority, SeaTac Shuttle provided several letters from members of the public who live in the communities involved. Their letters indicate a need for service that is currently not served on the route.
- The Commission, having considered the application and being fully advised, finds that SeaTac Shuttle is fit, willing, and able to provide the proposed service and that the proposed service is necessary and will be a convenience to the public.
- After reviewing the evidence submitted and due to the fact that no service of this nature is presently available over this route, the Commission will issue the requested authority.

## **ORDER**

## THE COMMISSION ORDERS:

The application filed by SEATAC SHUTTLE, LLC, d/b/a WHIDBEY SEATAC SHUTTLE, in Docket TC-180065, is granted, conditioned upon compliance with the laws and rules governing passenger transportation companies, and that passenger transportation company certificate C001077 is amended to read as follows:

AUTO TRANSPORTATION SERVICE by reservation only:

BETWEEN: Whidbey Island and Seattle.

CLOSED DOOR SERVICE BETWEEN: Seattle and the SeaTac International Airport. No passengers may be transported between points in Seattle and SeaTac International Airport.

PASSENGER SERVICE by reservation only:

AIRPORTER PASSENGER SERVICE BETWEEN: Whidbey Island and SeaTac International Airport via Deception Pass or the Clinton Ferry; Door to door service in conjunction with the above route; Oak Harbor and Lupien Field.

AUTO TRANSPORTATION SERVICE by reservation only:

BETWEEN: Oak Harbor and Coupeville; Coupeville and the Keystone Ferry; Langley and Clinton.

BETWEEN: Oak Harbor and hotels and motels within a 1-mile radius and hotels and motels within a 1-mile radius of the SeaTac International Airport.

CLOSED DOOR SERVICE: BETWEEN Deception Pass and SeaTac International Airport and BETWEEN the Clinton Ferry and SeaTac International Airport.

SCHEDULED PASSENGER SERVICE by reservation only:

AIRPORTER PASSENGER SERVICE BETWEEN: Whidbey Island and Paine Field Airport.

CLOSED DOOR SERVICE BETWEEN: Deception Pass and Paine Field and BETWEEN the Clinton Ferry and Paine Field.

NOTE: Nothing in this certificate authorizes transportation between SeaTac International

Airport and hotels and motels within a 1-mile radius of SeaTac.

6 (2) The tariff and time schedule filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this Order.

**NOTICE:** This is an order delegated to the Secretary for decision. In addition to serving you a copy of the decision, the Commission will post on its Internet Web site for at least 14 days a listing of all matters delegated to the Secretary for decision. You may seek Commission review of this decision. You must file a request for Commission review of this order no later than fourteen (14) days after the date the decision is posted on the Commission's Web site.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 24, 2015.
