





ATTACHMENT 5

STATEMENT OF EMERGENCY FUNCTIONALITY

U.S. Cellular's network is engineered to remain functional in emergency situations. U.S. Cellular builds sites with at least eight hours of battery back-up power to ensure functionality without an external power source. In most cases, U.S. Cellular can reroute traffic around damaged facilities and is capable of managing traffic spikes resulting from emergency situations. U.S. Cellular deploys the use of redundant physical and logical transport routing that automatically detects and reroutes traffic during a failure.

Most U.S. Cellular "hub" sites include permanent backup generators. Other sites are served by portable generators to restore power during an extended outage. These back-up power generators are capable of keeping a cell site up and running until power is restored to the cell site, and until system changes are made to reroute traffic. Back-up power generators are tested regularly to maintain functionality.

U.S. Cellular can rapidly deploy cell sites on light trucks ("COLTs") to restore service, add additional capacity or provide enhanced coverage in an emergency. These COLTs act as temporary cell sites when existing facilities are damaged or out of service for longer periods of time. In most cases, U.S. Cellular is capable of and will reroute traffic around damaged or out-of-service facilities by changing call routing translations as needed.

By changing call routing translations and/ or deploying COLTs, U.S. Cellular can effectively manage traffic spikes throughout its network. As a long-term solution for managing increased traffic levels and traffic spikes, U.S. Cellular will increase capacity at its cell sites, switches and transport facilities as needed.

Additionally, U.S. Cellular deploys a national disaster recovery program during large network impacting events including widespread power outages or widespread flooding. Moreover, U.S. Cellular is a signatory to the FCC's <u>Wireless Resiliency</u> <u>Cooperative Framework</u> that sets out a five-pronged approach for enhancing coordination during an emergency and also regularly participates in the Edison Electric Institute's cross-sector resiliency forums with the communications and electric sectors to explore restoration practices and discuss how to improve communications and coordination before, during and after a disaster.

United States Cellular Corporation SAC 529001 Form 481 Section 920 – Tribal Engagement

<u>Line 920 – Tribal Engagement</u>

United States Cellular Corporation ("U.S. Cellular" or the "Company") serves Tribal lands in Washington (SAC 529001) that are within the jurisdiction of the Confederated Tribes of the Chehalis Reservation, the Confederated Tribes and Bands of the Yakama Nation, the Quinault Tribe of the Quinault Reservation, the Shoalwater Bay Tribe of the Shoalwater Bay Indian Reservation, the Squaxin Island Tribe of the Squaxin Island Reservation, and the Skokomish Indian Tribe of the Skokomish Reservation (the "Tribal Governments"). For purposes of fulfilling its Tribal engagement obligations, as adopted by the Commission, each year, from 2012 through 2020, representatives of the Company made multiple attempts to engage the Tribal Governments in discussions regarding its wireless service and potential benefits to the Tribal lands.

The topics for proposed discussion were: (1) needs assessment and deployment planning with a focus on Tribal Government community anchor institutions; (2) feasibility and sustainability planning; (3) marketing services in a culturally sensitive manner; (4) rights of way processes; (5) land use permitting requirements; (6) facilities siting rules; (7) environmental review processes; (8) cultural preservation review processes; and (9) Tribal Government business and licensing requirements.

U.S. Cellular contacted the Tribal Governments via certified letter on November 12, 2012 and again, with a follow up letter on December 21, 2012, January 14, 2014, August 28, 2014, August 27, 2015, August 26, 2016, August 25, 2017, August 27, 2018, September 6, 2019, and September 2, 2020, to request a meeting to discuss the above matters. U.S. Cellular received no response to its multiple requests to engage the Tribal governments in discussions.
