Note 2: For service more frequently than weekly, multiply the above rates by the number of times per week service is required.

Note 3: A re-delivery fee of **\$17.00** will be assessed to cart customers whose service is discontinued for non-payment or cart customers who request re-delivery. See also Item 52.

Note 4: For those customers who do **not** receive garbage service, add **\$0.90** to the rates on page s 22 for both recycling and yard waste services.

Note 5: Regularly scheduled yard waste customers who request an additional 96-gallon cart will be assessed a monthly fee of **\$ 8.60** for each additional cart requested.
