Company proposes to change Tariff Number 14

The company requests Commission approval to amend its filed Tariff Number 14 on Less Than Statutory Notice to increase its Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$3.2655 per gallon for the base period to \$4.1435 per gallon current price. The proposed change is to implement a 0.25% surcharge in Supplement 3. Special Fuel Surcharge Supplement No. 2 will expire on May 31, 2024. The company request less than statutory notice allowing the customers to be noticed on the first bill as previously allowed per WAC 480-70-271(2)(a).

Customers who are billed monthly for services in arrears: The fuel surcharge applies to all services provided in the months of June 2024 and July 2024.

Customers who are billed bi-monthly for services – current month and one month in advance:

July 31, 2024	July 2024, and August 2024
