* Company proposes to change (Include Title of Provision, Tariff number and Sheets/Pages being changed): RCW 81.28.050 - The 45 day notice to customers
* Present provisions are: A 45 day notice to customers
* Proposed changes are: As stated in WAC 480-70-271 (2)(a), we are requesting to be allowed to notify customers on their first bill.
* Explain why the company is proposing this tariff revision: Recent potential interpretations of RCW 81.28.050 make it unclear whether the long-standing practice of following WAC 480-70-271 (2)(a) can be done without a L.S.N. form when submitting a disposal-only rate filing.
* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste): We have not requested the revision of rates to take effect in less than 45 days, we are asking that the customer notice can be completed as outlined in WAC 480-70-271 (2)(a)
