2. <u>Petitioner's Interest in this Proceeding</u>. AT&T is the purchaser of the Mass Market Fiber assets from Qwest Corporation, d/b/a CenturyLink QC ("<u>CenturyLink</u>"), the subject matter of this proceeding, and AT&T has a direct interest in the Commission's decision in this proceeding. AT&T is a subsidiary of AT&T Inc., a global leader in telecommunications and technology. AT&T and its affiliates provide wireless

and wireline telecommunications and broadband services to consumers located in the United States and businesses globally. AT&T's Consumer Wireline business provides wireline broadband services, fixed wireless broadband services, and legacy telephony voice communication services to residential customers in states other than Washington; its Business Wireline division offers advanced fiber services, fixed wireless services, IP Voice and managed professional services, as well as legacy voice and data services and related equipment, to enterprises in states other than Washington; and its Mobility business provides wireless service and equipment nationwide. ²

- 3. Petitioner's Position with Respect to the Matters in Controversy. AT&T's position with respect to CenturyLink's application is that the proposed transaction is in the public interest and should be approved on an expedited basis. Not only will CenturyLink's AFOR customers suffer no harm as a result of the transaction, the public will benefit greatly from AT&T's acquisition of the Mass Market Fiber assets from CenturyLink. AT&T's position is that consumers and the economy in Washington state will all gain from the proposed transaction. AT&T's financial resources, expertise, and experience will take CenturyLink's Mass Markets fiber business to the next level. The combination will bring increased infrastructure investment and faster deployment of high-speed fiber internet access.
