- 2 PROCEEDINGS
- 3 JUDGE HAENLE: The hearing will come to
- 4 order. This is a pre-hearing conference in Docket No.
- 5 UT-931591, which is the petition of GTE Northwest,
- 6 Incorporated for review of its authorized rate of
- 7 return. This pre-hearing conference is taking place
- 8 in Olympia, Washington on April 27, 1994 before
- 9 Administrative Law Judge Alice L. Haenle of the Office
- 10 of Administrative Hearings. The judge assigned to
- 11 this case is actually Heather Ballash. I am filling
- 12 in because she was scheduled out of the office today,
- 13 so any of your correspondance which you would send a
- 14 copy to the Administrative Law Judge, please make it
- 15 to Heather Ballash and not me.
- 16 Like to take appearances, please, beginning
- 17 with the representative for the company.
- 18 MR. POTTER: Richard Potter and Thomas
- 19 Parker, attorneys for GTE Northwest Company.
- JUDGE HAENLE: Address?
- MR. POTTER: My address is 1800 41st
- 22 Street, Everett, Washington and Mr. Parker, who will
- 23 actually be handling the hearings for us, is from
- 24 Irving, Texas office, 600 Hidden Ridge, Irving, Texas,
- 25 75038.

- 1 MR. TROTTER: Your Honor, just for the
- 2 record, I think it's usually customary for each party
- 3 to designate one individual just so that the paper flow
- 4 goes one way.
- 5 JUDGE HAENLE: That's right. Let's do that
- 6 after we take appearances. I will ask you to -- let's
- 7 give the full address and then I will ask you to
- 8 specify one person from your organization to act as the
- 9 contact person. Service upon that single person will
- 10 constitute service upon the company so that we're not
- 11 chasing papers all around. Mr. Smith.
- 12 MR. SMITH: Steven W. Smith, assistant
- 13 attorney general, South 1400 Evergreen Park Drive
- 14 Southwest, Olympia, Washington 98504, appearing for the
- 15 Commission staff. Also appearing is Gregory Trautman,
- 16 TRAUTMAN, assistant attorney general.
- JUDGE HAENLE: Thank you. Mr. Trotter.
- 18 MR. TROTTER: For office of public counsel,
- 19 I'm Donald T. Trotter, assistant attorney general.
- 20 Address is Suite 2000, 900 Fourth Avenue, Seattle,
- 21 Washington, 98164-1012.
- 22 JUDGE HAENLE: Thank you. As Mr. Trotter
- 23 says, I would like you to specify a single person from
- 24 your organization.
- MR. POTTER: That could be me, Richard

- 1 Potter.
- JUDGE HAENLE: Mr. Potter, for the company.
- 3 Mr. Smith.
- 4 MR. SMITH: Myself, Steven Smith, for the
- 5 staff.
- 6 JUDGE HAENLE: And Mr. Trotter, since you're
- 7 here by yourself, I assume it's you.
- 8 MR. TROTTER: Yes.
- JUDGE HAENLE: Is there anyone present in
- 10 the hearing room who intends to intervene in this
- 11 matter?
- I hear no response. Did anyone receive a
- 13 written petition to intervene that I haven't seen?
- MR. POTTER: No.
- 15 JUDGE HAENLE: I will check again to see if
- 16 there's anybody that shows up then. There are a number
- 17 of procedural-type things that we normally do at a
- 18 pre-hearing conference. One of those is to ask whether
- 19 anyone wants the rule on discovery to be invoked in
- 20 this matter.
- MR. SMITH: Your Honor, we would request
- the discovery rule be invoked and we're not requesting
- 23 any specific discovery schedule other than the 10-day
- 24 response time provided by the discovery rule itself.
- JUDGE HAENLE: I think this is an

1 appropriate case for the discovery rule. Is that all

- 2 right with you, Mr. Potter?
- 3 MR. POTTER: Yes.
- 4 JUDGE HAENLE: And you, Mr. Trotter?
- 5 MR. TROTTER: Yes.
- JUDGE HAENLE: Anyone going to be requesting
- 7 a protective order?
- 8 MR. POTTER: I don't believe so, at this
- 9 time.
- JUDGE HAENLE: Anyone? Okay, remember
- if you haven't requested a protective order, if
- 12 anything is requested that you consider confidential,
- 13 you will need to request a protective order from the
- 14 Commission.
- MR. POTTER: Understand.
- 16 JUDGE HAENLE: Before we went on the record,
- 17 I read you the schedule that I was just given at
- 18 lunchtime today. I've asked that you double-check
- 19 your schedules and if you find that there is a
- 20 conflict, you would need to let the Commission know
- 21 immediately and provide alternate dates to the
- 22 Commission. Pre-hearing conference, of course, is
- 23 scheduled for today. Cross of the company testimony,
- 24 June 20 and 21. Prefiling of staff, intervenor and
- 25 public counsel testimony, July 20. Cross of staff,

1 intervenor and public counsel testimony, August 15 and

- 2 16. Prefiling of company rebuttal, September 6. Cross
- 3 of company rebuttal October 3 and 4, anticipating
- 4 briefs due on October 31. We've got some prefiled
- 5 material that was distributed some time ago back in
- 6 December, and you have brought with you revisions to
- 7 that. Do you want to explain that, please, Mr. Potter?
- 8 MR. POTTER: The case concerns rate of
- 9 return and the recommendations are based on various
- 10 financial information and in the several months since
- 11 the application was filed the financial information on
- 12 which our witness, Mr. Hanley, would base his
- 13 recommendation has changed significantly enough that
- 14 Mr. Hanley and the company felt it was appropriate to
- 15 update that information and update his recommendation
- 16 accordingly.
- 17 JUDGE HAENLE: The materials that you've
- 18 brought with you are entitled Revised Exhibit whatever
- 19 and in answer to question from one of counsel present
- 20 you indicated that you did not comply with the rule
- 21 which requires that you underline and specify if there
- 22 are portions of testimony that are revised; is that
- 23 right?
- 24 MR. POTTER: Yes. We discussed that off the
- 25 record.

- 1 JUDGE HAENLE: And I indicated off the
- 2 record that you need to provide to counsel indications
- 3 which of the portions of the testimony specifically
- 4 have been revised so they don't have to hunt through
- 5 and compare, and next time, if you bring any revisions
- 6 you're going to be sure to comply with the rule which
- 7 specifies that you have to show on the revised
- 8 materials which portions have been revised.
- 9 MR. TROTTER: Is there a due date on that
- 10 response?
- 11 JUDGE HAENLE: How long will it take you
- 12 to do that? I assume not more than a couple of days.
- 13 Mr. Potter, can you have that in by Friday?
- 14 MR. POTTER: Middle of next week? Friday
- 15 would be tough.
- 16 MR. TROTTER: If they can fax it by a week
- 17 from today, that would be acceptable to us.
- 18 JUDGE HAENLE: I don't have my calendar
- 19 here. That would be next Wednesday then.
- 20 MR. POTTER: The methods and models and so
- 21 on that the witness used have not changed, but the
- 22 numbers that were input have changed.
- JUDGE HAENLE: So those would be due next
- 24 Wednesday, and if you do any of these again, remember
- 25 that all of your copies need to be marked in that same

- 1 manner.
- 2 While we were off the record then I marked
- 3 for identification the three documents as follows: T-1
- 4 is SPS, revised testimony; T-2 is FJH, revised
- 5 testimony; and 3 is FJH-1 which is a group of exhibits,
- 6 a number of schedules included in that exhibit.
- 7 Will the provision of those interlineations
- 8 take care of your concerns about the revisions,
- 9 Mr. Trotter?
- 10 MR. TROTTER: Hopefully. I anticipate it
- 11 will.
- JUDGE HAENLE: For you, Mr. Smith?
- 13 MR. SMITH: That should be fine, yes.
- 14 JUDGE HAENLE: I will remind you that
- 15 responses to staff data requests need to be sent
- 16 directly to Mr. Smith. Don't funnel those through the
- 17 secretary's office because those are not necessarily
- 18 made part of the record. Be sure they go directly to
- 19 Mr. Smith.
- 20 Are there any other matters that we need to
- 21 discuss in perms of the pre-hearing conference? I
- 22 asked if there were any issues that you wanted to work
- 23 on delineating since the notice of hearing says that
- 24 we'll delineate issues. Anyone have any ideas? Okay.
- 25 Hearing nothing, then, let me check again and see if
