## **Recommendation**

Allow the tariff pages filed by Roche Harbor Water System on February 25, 2021, to become effective April 22, 2021, by operation of law.

### **Background**

On February 25, 2021, Roche Harbor Water System (Roche Harbor or company) filed with the Utilities and Transportation Commission (commission) a tariff revision that as stated in the company cover letter would generate approximately \$71,000 (16.6 percent) additional annual revenue. Review by commission staff (staff) found that the proposed rates will generate approximately \$88,000 (22 percent) of additional annual revenue. The company serves 624 customers in San Juan County.

The company's last rate increase which provided \$35,594 of additional annual revenue became effective March 1, 2012. The main reason for the current filing is general increases in operating expense and significant investment in assets since the 2012 rate case.

The company has a surcharge currently in place on each 1000 gallons of usage and it will remain the unchanged. This surcharge expires November 30, 2023, upon recovery of the \$1,634,700 DWSRF Loan which was borrowed to build the treatment plant and new 12" main in 2003. Additionally, the company will be adjusting some of the ancillary charges to help recover cost directly incurred by customers.

After review, staff found the company's books and records supported the company's request and the proposed rates were fair, just, reasonable, and sufficient. The company made significant infrastructure upgrades replacing water mains adding a Supervisory Control and Data Acquisition (SCADA) system and replacing boosters and pumps. Staff's review showed the company was entitled to additional annual revenue above the amount requested. The company was made aware of this and decided to continue with the request as filed and come back at another time to request the remaining revenue.

#### **Customer Comments**

On February 25, the company notified its customers by mail of the proposed rate increase. Staff received no comments.
