Hopefully, the judge and UTC will see that our actions speak louder than our words and grant us mitigation on these penalties.

Additionally, we request the court to take into consideration the proof provided that the violation for failing to provide an annual inspection for truck #1 should be negated based on the fact that at the time, we were not in violation of this offense.
