Dear Mr. Danner,

On June 16, 2011, the Washington Utilities and Transportation Commission granted YourTel America ETC status in the State of Washington via an Order effective that day. It included language that YourTel is to abide by the following:

YourTel shall file with the Commission any future changes to its rates, terms, or conditions at least one day prior to the effective date of the change.

YourTel America hereby places on file the following new plans to be offered to qualified Lifeline residents of YourTel America's designated service areas. Supplemental pieces of YourTel's existing plans, such as features, 611 and 911 calling and roaming apply to these plans and remain unchanged.

Lifeline Unlimited – Non-Tribal Areas

Unlimited voice and/or text minutes at \$27.50 per month. One text message is equivalent to one minute of use.

Lifeline 1000– Non-Tribal Areas

1000 voice or text minutes at \$27.25 per month. One text message is equivalent to one minute of use. Any unused minutes are available for a maximum of 30 days and do not roll over.

### Lifeline 1000 Data- Non-Tribal Areas

1000 voice or text minutes and unlimited data at \$32.25 per month. One text message is equivalent to one minute of use. Any unused minutes are available for a maximum of 30 days and do not roll over.

# Lifeline 1000 Data-Tribal Areas

1000 voice or text minutes and unlimited data at \$5.00 per month. One text message is equivalent to one minute of use. Any unused minutes are available for a maximum of 30 days and do not roll over.

#### Lifeline Unlimited Data – Non-Tribal Areas

Unlimited voice and/or text minutes and unlimited data at \$32.50 per month. One text message is equivalent to one minute of use.

# Lifeline Unlimited Data - - Tribal Areas

Unlimited voice and/or text minutes and unlimited data at \$10.75 per month. One text message is equivalent to one minute of use.

### Lifeline 250 Data - - Non-Tribal Areas

250 voice or text minutes and 10MB of data at no charge.

# Additional Data Top-Up Plans

250 MB	\$10.00	30 days plan life
500 MB	\$20.00	30 days plan life
1 Gig	\$40.00	30 days plan life

These changes are effective February 28<sup>th</sup>, 2013.
