Re: KCHA-Colluded Imposition of Weaponized Electronic Meters on Tenants/Employees

To Whom It May Concern – If Anyone:

On January 3, 2019, a potentially fatal fire broke out in one of the building wings of Casa Madrona, the KCHA-managed senior/disabled-occupied property in Olympia. It was caused by a medical oxygen tank catching fire in the apartment of a tenant many times reported to KCHA management as smoking in her unit, thus putting herself, 68 other tenants and the building itself at risk. Only divine intervention stopped the potentially devastating explosion of that oxygen tank, and nearly two weeks later, that tenant is now still possibly displaced, and the lives of neighboring tenants still being disrupted. KCHA management had long decided to do nothing, maintaining that the repeated, factually consistent “nose” witness testimonies of multiple tenants – admissible in a court of law – were not sufficient to warrant investigation and/or intervention by KCHA management before such a potentially fatal fire occurred. We now have seen the outcome of this decision: a violation of a key KCHA/HUD rental contract clause, which states that KCHA shall provide a safe and secure environment for their tenants.

KCHA Southwest Regional management was informed that there was a second, simpler solution to frequent KCHA late fees being imposed on some of Casa Madrona’s low-income senior tenants. This was being caused by both by their monthly Social Security payments not being paid them until the 3rd of each month, as well as Casa Madrona’s location being more remote than any other KCHA-managed property. KCHA management/staff were informed that a credit union located just down the street from Casa Madrona – and with branches throughout KCHA’s service area – offered an “early pay” option that could completely eliminate this problem, without these tenants having to resort to KCHA’s “direct pay” option, automatically taking money from their bank accounts each month, to which many of these senior tenants on limited incomes understandably have objected.

Significantly, KCHA Southwest Regional management decided not to distribute any information on this “easy pay” option to their tenants. They are evidently concerned that a referral to a local non-profit credit union would deprive the international for-profit banking cartel of yet more of the accrued interest on seniors’ Social Security checks to which they feel entitled, as well as deprive KCHA of more operating revenue from their exorbitant late fees on low-income seniors’ Social Security-dependent monthly incomes. Or perhaps these KCHA employees were concerned about invoking institutional wrath from their bureaucratic employer for showing any humanely effective, innovative initiative on their tenants’ behalf.

Most egregiously, KCHA Southwest Regional management/staff had for the past three years been repeatedly given evidence concerning the dangers of “smart” utility meters and the need to opt out of these dangerous digital surveillance devices to protect their tenants, themselves and their fellow employees. They had stated that they would pass this evidence on to KCHA’s top management. Then, when questioned about this in the last quarter of 2018, they admitted to not reading anything they had been given, or even watching the free award-winning online documentary available to help themselves be informed about this issue. This indicated that, as with the late fee information, they likewise had not passed on this critically important information concerning “smart” meters.

Further, a tenant-generated letter dated October 29, 2018, asked KCHA's board of directors/top management a series of tenant questions about what the effects of Puget Sound Energy imposing "smart" utility meters in their rental properties/workplaces might be. One of KCHA's deputy executive directors responded with energy industry/corporate government/media propaganda, indicating that they, like their lower-level management, had declined to perform due diligence with any credible research being done by themselves. This again violated the KCHA/HUD rental contract, which states that KCHA shall provide a safe and secure environment for their tenants – and implicitly for themselves and their employees. Such a robotic, patronizing response from those whom, without real knowledge or receptivity, presume to know better than those whom they supposedly serve what is best for them – with now-demonstrated danger to all concerned -- merited a crystal clear and coldly factual methodology and intent in this reply, which is as follows:

First, to provide some credible weblinks in an appendix enclosed with this letter, as a rebuttal to your energy industry/corporate government/media propaganda-based assertions as to the safety, reliability, security and lawfulness of weaponized electronic utility meters. These are only the tip of the telecommunications/energy industry's and their captured government agencies' deadly dark iceberg of suppressed forensic evidence that you and your colleagues at KCHA headquarters obviously have made no serious efforts whatsoever to uncover;

Second, there is a definite deliberate intention in sending the King County Housing Authority Board of Directors/other KCHA top management/other interested parties this reply, with relevant evidentiary weblinks, delivered by traceable, documented certified postal mail. It is to thereby serve notice and to provide a documented basis for legal action citing willful/criminal malfeasance, should the KCHA Board of Directors/top management collude with Puget Sound Energy (PSE) and the telecom/energy industry-controlled Washington State Utility and Transportation Commission (WUTC) in attempting to impose, without tenant consent, weaponized electronic utility meters on the senior/disabled residents of the Casa Madrona Apartments in Olympia, Washington State – in a manner similar to how that potentially fatal fire was imposed on them by fear-based, bureaucratic apathy and inertia on January 3, 2019. And such danger potentially will exist again – if weaponized electronic meters with, among their many other problems, a well-documented history of the deadly fires that they have caused – are arrogantly imposed on the low-income senior/disabled tenants of Casa Madrona without KCHA setting sound US public housing precedent, by, at the very least, seeking opt-outs for their tenants as has been responsibly and reasonably requested.

For over three years, it had been a great pleasure to deal in a cordial, forthright manner with the property management, as well as the social and maintenance services, of the Southwest Region of the award-winning King County Housing Authority (KCHA), and more recently, with one of their upper-level supervisors. Unfortunately, now that I have had to deal with KCHA management and board of directors concerning this particular matter, I sincerely regret that -- despite my best efforts to demonstrate good faith and fairness – this does not seem to be reciprocated by the King County Housing Authority Board of Directors and management. Unfortunately, KCHA, despite its many virtues, fundamentally seems still to be operating from a medieval military paradigm of command and control in a supposedly modern, democratic country. America, because of the actual – not idealized -- fear-based feudal form of its failing institutions, has, in such major matters as protecting the safety and security its people, finally become the land of the fee and the home of the slave.

Dear Ms. Campbell:

Thank you for bringing your concerns forward regarding Puget Sound Energy's (PSE) plan to replace existing electric meters with new "smart" meters. As mentioned in your letter, we take the condition of our properties and the safety of our residents very seriously.

In response to your letter dated October 29, 2018, we have contacted PSE and Seattle City Light, as well as reviewed information available from the Washington Utilities and Transportation Commission (WUTC). In addition to our own research, these agencies assure us that the meters in consideration operate on low-level radio frequency (RF) transmission signals that fall well within the FCC's acceptable thresholds. These meters emit substantially less RF energy, and for shorter durations, than other regularly used household electronics such as cell phones, radios, cordless phones, Bluetooth devices, microwaves, and Wi-Fi.

The reliability of these new smart meters is an issue that both KCHA and the utility care about. The meters are rigorously tested by the utility for accuracy and will undergo regularly scheduled quality assurance inspections to confirm that they are correctly reading and relaying consumption data. Please note that it is the responsibility of the electric utility to maintain these meters, and if they have a shorter lifespan than the previous meters, it is the utility's responsibility to replace them at no cost to their customer or a property owner.


With regards to your concern that the meters are a possible security threat to private information, PSE prioritizes data security and has a comprehensive cyber-security program that adheres to national standards for companies that work in the energy industry. Per PSE's website, "Personal information, such as your name and address, is not stored on the meters nor transmitted through the meter network." In other words, if there is a hacking of personal information at PSE, it won't be due to the new meters since they don't possess any personally identifiable information, and you are no more at risk of hacking of personal information from the utility's main data system than you would be with an analog meter.

Regarding opting out of the installation, we have been told that PSE is developing a way for property owners to opt out, as required by WUTC. Currently, KCHA is not planning to opt out. You also raised a concern regarding the co-location of the meters violating the FCC Grants of Equipment Authorization. While we do not have any specific details on PSE's protocols and procedures to stay FCC compliant, they are regulated by WUTC, which oversees and requires FCC compliance.

If you have any questions about smart meters, their installation, or operation, I encourage you to contact PSE directly, as they are best positioned to address all of your concerns in full.
