TO ALL INTERESTED PERSONS:

On December 30, 2021, PacifiCorp, d/b/a Pacific Power & Light Company, (PacifiCorp or Company) filed its Clean Energy Implementation Plan (CEIP) with the Washington Utilities and Transportation Commission (Commission) pursuant to WAC 480-100-640.

The Company originally filed its Public Participation Plan in Docket UE-210305. As part of its CEIP, PacifiCorp updated its public participation commitments and responded to stakeholder comments in Chapter Five and Appendix A, respectively.

Interested persons may submit written comments on PacifiCorp's CEIP **no later than 5 p.m. Friday, May 6, 2022**. Pursuant to WAC 480-07-140(5), written comments must be submitted in electronic form, specifically in searchable .pdf format (Adobe Acrobat or comparable software). Those comments must be submitted via the Commission's web portal at <http://www.utc.wa.gov/e-filing>. If you are unable to submit documents via the portal, you may submit your comments by email to the Commission's Records Center at [records@utc.wa.gov](mailto:records@utc.wa.gov). Comment submissions should include:

- the docket number (Docket UE-210829),

- the title and date of the comment or comments.
