The above-entitled matter, which is in the nature of a complaint against Seattle Disposal Company, Rabanco Ltd., d/b/a Eastside Disposal and Container Hauling, was filed on March 23, 1994. The pleadings indicate a dispute exists between complainant and respondent relating to tariff revisions adopted in Docket No. TG-931585.

Pursuant to the first notice of hearing herein, a prehearing conference was held on May 9, 1994. At that time petitions to intervene were considered and appearances of the different parties were received. It is now appropriate that provision be made for hearing for receipt of the direct evidence of the complainant and the staff of the Commission and all other parties and cross-examination thereof; for receipt of rebuttal evidence of the complainant, if any, and the cross-examination thereof; and the receipt and cross-examination of evidence presented by members of the public.

NOTICE IS HEREBY GIVEN That public hearings herein will be reconvened at the hour of 9:30 a.m., Thursday, July 14, 1994, in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington. Beginning at such time and place and continuing for such period of time as may be necessary, the Commission will hear the direct testimony of witnesses for all parties, including the staff of the Commission, and the cross-examination thereof, except members of the public (for whom special provision is hereinafter made); and rebuttal evidence of complainant, if any, and the cross-examination thereof. Complainant made predistribution of its testimony in prepared form and exhibits to the Commission and all parties on

May 16, 1994; the staff and respondents made predistribution of their testimony in prepared form and exhibits to the Commission and all parties on June 20, 1994. Any rebuttal evidence shall be predistributed not later than July 7, 1994.

NOTICE IS FURTHER GIVEN That a public hearing will be reconvened at the time and place listed below for the receipt of testimony and exhibits, if any, of members of the public who may wish to give testimony in this matter and the cross-examination thereof.
