1 **Synopsis:** *This order amends Order No. 04 to add docket Nos. UE-011570 and UG-011571 to the caption to implement the portion of Order No. 04 that affects the prior dockets.*

2 On October 20, 2005, the Commission entered Order No. 04 in this proceeding, approving and adopting settlement agreement, authorizing and requiring compliance filing, and granting other relief.

- 3 In paragraph 47 of Order No. 04, the Commission ordered that Docket Nos. UE-011570 and UG- 011571 be reopened for the limited purpose of amending the Commission's Twelfth Supplemental Order. Specifically, the Commission amended the Twelfth Supplemental Order "to authorize changes to PSE's PCA Mechanism as set forth in Section F of the Settlement Agreement, paragraphs 16-19."
- 4 Those changes include a change in the annual PCA period to a calendar year beginning January 2007, annual PCA true up filings due by the end of each March for the prior PCA calendar year, and a 50 per cent cut in the sharing bands under the PCA mechanism for the six-month period of July 1, 2006 through December 31, 2006.
- 5 The Commission's change to the process adopted in its prior Order in Docket Nos. UE-011570 and UG-011571 should be memorialized in those dockets. Accordingly, this Order amends Order No. 04 to add Docket Nos. UE-011570 and UG-011571 to the caption to implement the portion of Order No. 04 that affects the prior dockets.
- 6 In all other respects, Order No. 04 remains unchanged. This Order does not impact the effectiveness of Order No. 04, or PSE's compliance filing in Docket No. UE-050870.
