1 Pursuant to WAC § 480-07-375, the Alliance of Western Energy Consumers (“AWEC”) respectfully requests that the Commission modify the procedural schedule in the above-referenced docket, cancelling the June 7, 2024, Non-Company Party Settlement Meeting and the June 14, 2024, First Settlement Conference. As a result, the August 14, 2024, Non-Company Party Settlement Meeting would be maintained and the August 19, 2024, Settlement Conference would be the First Settlement Conference. AWEC has conferred with the parties to this proceeding, and no party has indicated that they oppose the requested schedule change.
