- I On February 15, 2024, Puget Sound Energy (PSE or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective Tariff WN U-60, Tariff G, Electric Service, and its currently effective Tariff WN U-2, Natural Gas.
- On April 18, 2024, the Commission entered Order 04/02, Prehearing Conference Order and Notice of Hearing (Order 04/02), scheduling an evidentiary hearing for November 4-5, 2024, at 9:30 a.m. As relevant here, the schedule included a non-Company party settlement meeting on June 7, 2024, and a first settlement conference on June 14, 2024.
- 3 On June 6, 2024, Alliance of Western Energy Consumers (AWEC) filed a Motion to Amend Procedural Schedule. AWEC proposes cancelling the non-Company party settlement meeting on June 7, 2024, and a first settlement conference on June 14, 2024. The August 14, 2024, non-Company party settlement meeting would remain on the

schedule and the August 19, 2024, settlement conference would then be the first settlement conference in this docket. AWEC indicates that it has conferred with the other parties, who did not oppose this motion.

DISCUSSION

We grant AWEC's Motion to Amend Procedural Schedule. Pursuant to WAC 480-07-700(5)(a), the schedule for any adjudication should include at least one settlement conference. AWEC submits that the parties will benefit from discussing settlement slightly later in the schedule in this case, and it represents that this motion is unopposed by the other parties. The procedural schedule should be amended as requested by AWEC.

- 5 (1) The Alliance Western Energy Consumer's Motion to Amend Procedural Schedule is GRANTED.
