Level 3 Communications, Inc. ("Level 3") supports the requests of AT&T Communications of the Pacific Northwest, Inc., NEXTLINK Washington, Inc., Advanced TelCom, Inc. ("Joint Intervenors") and the Northwest Payphone Association for a continuance of the date for filing of Staff, Public Counsel, and intervenor testimony. US WEST, Inc.'s and Qwest Communications International, Inc.'s ("Applicants") refusal to respond to numerous discovery requests makes it impossible for Level 3 as well as other parties to prepare and file testimony by November 22, 1999. Level 3 also agree's with Joint Intervenors that the Commission establish a date by which Applicants must provide responses to outstanding discovery requests and continue the testimony filing deadline until two weeks after that date.

Given that he Commission needs to schedule answers to the several pending motions to compel, it is unlikely the Applicants will respond in time to give Staff, Public Counsel, and intervenors the time necessary to review those responses and prepare testimony by November 22, 1999. And while Level 3 has not propounded discovery to date, it is evaluating outstanding discovery requests made by other parties in the preparation its testimony. Accordingly, Level 3

support's Joint Intervenors suggestion that the Commission set a date by which the Applicants must fully respond to the discovery subject to pending motions to compel, and to schedule the filing of testimony two weeks thereafter.

For the foregoing reasons, Level 3 supports the requests of Joint Intervenors and the Northwest Payphone Association to continue the case schedule adopted in this docket.
