TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in this rulemaking docket concerning whether new or revised regulations are needed to govern the Washington Utilities and Transportation Commission (Commission's) implementation of the Energy Independence Act (Act). The Act is the result of Initiative No. 937 that passed by public vote on November 7, 2006. The Act is now codified at RCW 19.285. This letter also provides notice of an opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing at 1:30 p.m. on October 24, 2007.

On August 21, 2007, the Commission filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Office of the Code Reviser. The proposal would establish the procedures investor owned utilities must follow to demonstrate compliance with the statutory requirements, and establish penalty provisions, as well as reporting and public notification requirements. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
