COMMISSION STAFF'S ANSWER TO CAPITAL AEROPORTER'S PETITION FOR ADMINISTRATIVE REVIEW

Speedishuttle Washington, LLC, applied for authority to provide door-to-door shuttle service between the Seattle-Tacoma International Airport and points within King County.

Two existing providers, Shuttle Express and Pacific Northwest Transportation Services,

Inc., d/b/a Capital Aeroporter, filed objections to Speedishuttle's application.

On January 22, 2015, following a brief adjudicative hearing, ALJ Rayne Pearson overruled both objections (Order 02) and referred the application to Staff for evaluation.

On February 11, 2015, Capital Aeroporter petitioned for administrative review.

Consistent with its stance at the brief adjudicative hearing, Staff declines to address the merits of Capital Aeroporter's objection. Accordingly, Staff takes no position regarding Capital Aeroporter's petition for administrative review.
