Amendment No. 17 amends Section 1 of the TRRO Amendment to the Interconnection Agreement as set forth in Section 1 of the attached amendment..

This amendment amends the interconnection agreement first approved by the Commission on August 30, 2000 in WUTC Docket No. UT-993007 (current docket number) between Qwest Corporation and McLeodUSA Telecommunications Services, Inc.
