- On November 19, 2003, Northwest Natural Gas Company (NW Natural) filed certain tariff revisions to its currently effective Tariff WN U-6, which would increase charges and rates for service provided by NW Natural by approximately 15 percent in the company's gas service Rate Schedules, and a total revenue increase of \$7,894,393 per year.
- 2 By order of the Commission, the operation of the tariff revisions have been suspended pending hearing or hearings concerning all such changes and the justness and reasonableness thereof.
- Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, RCW 34.05.452, and RCW 34.05.455. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of natural gas companies. The statutes and rules involved, in addition to those previously cited, include those within chapters 80.04, 80.16, and 80.28 RCW, and chapters 480-09, 480-80 and 480-90 WAC.

The ultimate issues include whether the proposed tariff revisions are just, fair, reasonable, sufficient, and in the public interest. The ultimate issues also include whether NW Natural's current rates on file and effect with the Commission are just, fair, reasonable, and sufficient. These issues include consideration of alternative rate design or structure. In accordance with the provisions of RCW 80.04.130 the burden of proof to show that the proposed general tariff revisions are just and reasonable shall be upon the respondent.
