TO INTERESTED PERSONS:

On August 1, 2003, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Code Reviser to amend WAC 480-120-146, Changing service providers from one local exchange company (LEC) to another. The proposed amendments would clarify the process to be followed when a customer migrates from one LEC to another LEC, and the customer retains his/her telephone number via Local Number Portability (LNP). Qwest Corporation initiated the proposed revisions in a petition to amend WAC 480-120-146, filed with the Commission on June 17, 2003. On July 31, 2003, the Commission granted Qwest's petition and directed the Secretary to file a Notice of Proposed Rulemaking.

The draft rule, as filed with the Code Reviser, is available for inspection on the Commission's web site at www.wutc.sw.gov/030964. The Commission will send you a paper copy of the draft rule or will send the proposal via electronic mail, if you ask.

WRITTEN COMMENTS.
