**NINTH AMENDMENT TO THE KIOSK SALES AGREEMENT**

This **AMENDMENT No.9** (the "Amendment") to the Kiosk Sales Agreement between the parties dated March 24, 2006, as amended (the "Agreement"), is made by and between Verizon Services Corp., on behalf of itself and its affiliates listed on Exhibit A with principal offices located at One Verizon Way, Basking Ridge, New Jersey 07920, ("Verizon") and Celco Partnership, a Delaware General Partnership, Dallas MTA LP, a Delaware Limited Partnership, and Oxnard-Ventura-Simi Limited Partnership, a California Limited Partnership, with principal offices at One Verizon Way, Basking Ridge, New Jersey 07920, collectively doing business as Verizon Wireless ("Verizon Wireless").

1. This Amendment is an integral part of the Agreement. The capitalized terms used herein which are defined or specified in the Agreement shall have the meanings set forth in the Agreement. If there are any inconsistencies between the provisions of this Amendment and the provisions of the Agreement, the provisions of this Amendment shall control.

2. Exhibit A of the Agreement is amended to (a) add new Stores, and (b) update the information for certain existing Stores. The Agreement is amended to add the following new parties:

3. The Agreement is amended to add the following new parties Section 16 of the Agreement is amended by adding a new subsection:

4. This Amendment shall be effective when executed by all parties and shall remain in effect until the Agreement terminates. With respect to any Store(s) added in the State of Oregon, the Effective date of this Amendment is subject to Section 5(a) of the Agreement.

5. All provisions of the Agreement not addressed by this Amendment remain in full force and effect.
