3. The temporary .72% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of September, October and November 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of January, February and March 2009.

Customers who are billed quarterly for services – one month in arrears, current month and one month in advance:
