Re: Replacement Pages for Docket #TC-111867 Fuel Surcharge Request and LSN for Pacific Northwest Transportation Services, Inc.

Mr. Danner:

Please find attached "Replacement Pages" for Docket TC-111867. Due to a calculation error the current fuel price on "FUEL PacNWTransp November 11" equals \$3.91. The effective Fuel Surcharge amount requested will be \$2.00 per one way passenger fare and \$4.50 per roundtrip passenger fare. The attached "AutoTransFuelSurchargeWorkbook" shows the effective difference making the same adjustment to the Fuel Surcharge Request. The company requests Commission approval to amend its filed Tariff No. 4 on Less Than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement No. 96 to recover the difference in current cost of fuel and the fuel costs embedded in the filed rates. We respectfully request approval and adoption of the attached replacement pages for "Fuel Surcharge Tariff Supplement" and "Docket A-042090 Fuel Surcharge LSN", with the LSN effective date of: 02 November 2011, to recover the risen cost of fuel.

The proposed fuel surcharge amount is \$2.00 per one way passenger fare and \$4.00 per round-trip passenger fare. The percentage amount that rates will change if "Special Fuel Surcharge Tariff Supplement No. 96" becomes effective will be as follows:

Minimum Percentage

Proposed Surcharge Amount	\$2.00
Divided by Highest Fare Amount	\$305.00 for 7 passengers from Fare Zone Z
Percentage Amount	4.59%

Maximum Percentage

Proposed Surcharge Amount	\$2.00
Divided by Lowest Fare Amount	\$20.00
Percentage Amount	10.00%

Revenue is expected to change, if the proposed rates become effective, as follows:

Base Year's Average Customer Count	2,639 per month
Multiplied by Proposed Surcharge Amount	\$2.00
Amount of Revenue	\$5,278.00
