1 On July 19, 2012, the Washington Utilities and Transportation Commission (Commission) issued a notice of its intention to deny Oracle Marketing, Inc. d/b/a Great American Moving & Storage’s (Oracle Marketing) application for permanent authority for failure to meet the application requirements in RCW 81.80 and WAC 480-15.

2 On July 27, 2012, Oracle Marketing filed with the Commission a request for a mitigation hearing. Ms. Green of Oracle Marketing states she would like the opportunity to dispute the Commission’s references to her company’s “history of noncompliance” and “harmful business practices.” Ms. Green further states that due to her travel schedule, she will not be available for a hearing for approximately 7 to 8 weeks after August 1, 2012.

3 Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether Oracle Marketing’s application for permanent authority should be denied for failure to meet the application requirements.

4 **THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 1:30 p.m., on Monday, October 8, 2012, in Room 108, First Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**

- 5 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
- 6 Written notice of any other stage in the proceeding or other formal proceedings that the Commission may deem appropriate will be given during the course of this case. The Commission will provide at its offices in Olympia, Washington, copies of documents in the current record for use by the parties or others who may want to review them.
- 7 Parties wishing to submit any other documents for consideration at the brief adjudicative proceeding must file with the Commission a list enumerating and describing any such documents **no later than 5:00 p.m. on Monday October 1, 2012**, and bring an original and **three (3)** copies to the hearing. Filing shall be in accordance with WAC 480-07-140 and – 145.
- 8 **THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.**
