- On July 19, 2012, the Washington Utilities and Transportation Commission (Commission) issued a notice of its intention to deny Oracle Marketing, Inc. d/b/a Great American Moving & Storage's (Oracle Marketing) application for permanent authority for failure to meet the application requirements in RCW 81.80 and WAC 480-15.
- On July 27, 2012, Oracle Marketing filed with the Commission a request for a mitigation hearing. Ms. Green of Oracle Marketing states she would like the opportunity to dispute the Commission's references to her company's "history of noncompliance" and "harmful business practices." Ms. Green further states that due to her travel schedule, she will not be available for a hearing for approximately 7 to 8 weeks after August 1, 2012.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether Oracle Marketing's application for permanent authority should be denied for failure to meet the application requirements.
