On November 1, 2013, Blue Jay Wireless, LLC ("Blue Jay" or "Company") submitted an update letter in connection with the Company's above-captioned petition for designation as an Eligible Telecommunications Carrier ("ETC") in Washington. The letter inadvertently included an error, listing a pending application in South Dakota, which in fact has not yet been filed. Blue Jay regrets the error and provides a corrected summary (including a subsequent filing) as follows:

• Since the Company's February 27, 2013 and May 17, 2013 updates to the Commission, which noted grants of ETC designation in Texas, Colorado, Rhode Island, South Carolina, Puerto Rico, Wisconsin, Nevada, and Missouri, Blue Jay has been granted ETC designation in the following jurisdictions: the State of Arizona,<sup>1</sup> the State of Hawaii,<sup>2</sup> the State of Minnesota,<sup>3</sup> the State of Oklahoma,<sup>4</sup> the Commonwealth of Pennsylvania,<sup>5</sup> and the State of Utah.<sup>6</sup>
