

- 5 Commission Staff (Staff) reviewed the tariff request together with other factors and recommended the Commission allow the tariff to become effective by operation of law, and grant the Company's request for an exemption from the WAC 480-07-520, work paper filing requirements for this filing for the following reasons:
- (a) There have not been any significant changes since the last rate case that became effective April 1, 2012. Reviewing the rate case documents, customer numbers are relatively unchanged, inflation has been low, and the Company has not changed its collection methods.
 - (b) The increased disposal fees are set by the Spokane Regional Solid Waste System and are required as a part of the Company's operations.
 - (c) The Company's financial information supports the proposed revenue requirement and the proposed rates.
 - (d) Staff concluded the proposed rate increase, by reason of the increase in disposal fees is fair, just, and reasonable.

FINDINGS AND CONCLUSIONS

- 6 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with the authority to regulate the rates, rules, regulations, practices, accounts and affiliated interests of public service companies, including solid waste companies. RCW 80.01.040, RCW 81.01, RCW 81.04, RCW 81.16, RCW 81.28 and RCW 81.77.
- 7 (2) Torre is engaged in the business of providing solid waste services within the state of Washington and is a public service company subject to Commission jurisdiction.
- 8 (3) Torre is subject to the filing requirements of WAC 480-07-520, for general rate increase proposals. The Company requested an exemption from WAC 480-07-520.
- 9 (4) Under WAC 480-07-110, the Commission may grant an exemption from the provisions of any rule in WAC 480-70, if consistent with the public interest, the purposes underlying regulation and applicable statutes. See also WAC 480-70-051.

- 10 (5) This matter came before the Commission at its regularly scheduled meeting on December 13, 2012.
- 11 (6) After review of the petition filed in Docket TG-121790 by Torre on November 13, 2012, and giving due consideration, the Commission finds:
- (a) The Company's request for an exemption from the general rate increase filing requirements set forth in WAC 480-07-520 is in the public interest and is consistent with the purposes underlying the regulation and applicable statutes and should be granted.
- (b) It is in the public interest to allow the revisions of Tariff No. 3 filed on November 13, 2012, December 6, 2012, and December 7, 2012, to become effective on January 1, 2013, by operation of law.

ORDER

THE COMMISSION ORDERS:

- 12 (1) After the effective date of this Order, Torre Refuse & Recycling, LLC, d/b/a Sunshine Disposal & Recycling is granted an exemption from WAC 480-07-520, for purposes of the tariff revisions filed in Docket TG-121790 on November 13, 2012, December 6, 2012, and December 7, 2012.
- 13 (3) The Commission retains jurisdiction over the subject matter and Torre Refuse & Recycling, LLC, d/b/a Sunshine Disposal & Recycling to effectuate the provisions of this Order.
- 14 (4) The Commission takes no action on the tariff revisions implementing the disposal fee increase and allows them to become effective on January 1, 2013, by operation of law.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
