Amendment Number: 1

Description of amendment: This Agreement is amended by adding the CenturyLink QC Performance Assurance Plan (PAP) language at Section 20.2, as set forth in Attachment 1, and by replacing Exhibit K, attached to the amendment.

The amendment amends the interconnection agreement approved by the Commission on November 30, 2012 in WUTC Docket No. UT-123022.
