- On May 27, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TE-141062 against Execuvan Rental LLC (Execuvan) in the amount of \$1,000, alleging a violation of WAC 480-30-071, which requires permitted charter and excursion carrier companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- On June 2, 2014, Execuvan filed with the Commission a request for hearing stating that they never received a letter about filing out an annual report. Execuvan goes on to say that they did change their mailing address after one of their partners left the company.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-30-071 occurred and, if so, whether the penalty should be mitigated.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m., on Tuesday, August 26, 2014, in Room 206, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.

- Parties wishing to submit any other documents for consideration at the brief adjudicative proceeding must file with the Commission a list enumerating and describing any such documents **no later than 5:00 p.m. on Tuesday, August 19, 2014**, and bring an original and three (3) copies to the hearing. Filing shall be in accordance with WAC 480-07-140 and 145.
- THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.
