NOTICE OF PROPOSED RATE INCREASE

Cascade Natural Gas Corporation proposes a .05 percent increase in natural gas rates.

On September 26 and September 28 of 2018, Cascade Natural Gas Corporation (Cascade) filed the following two separate requests with the Washington Utilities and Transportation Commission (WUTC) proposing an overall average .05 percent increase for all customer groups with natural gas service, effective December 1, 2018:

- Washington Energy Assistance Fund (WEAF) Program: Cascade requested an increase to the WEAF Program cost recovery adjustment. For the WEAF program costs alone, the average residential customer using 54 therms per month will see a bill increase of \$0.03 more per month or 0.05 percent.
- Important Tax Notice: For customers residing within the city limits of the following Washington State communities: Anacortes, Blaine, Bremerton, East Wenatchee, Kelso, Kennewick, Moses Lake, Port Orchard, Prosser, Sedro Woolley, Toppenish, Woodland, and Yakima Tiers I and II. Cities will see an increase in tax rate; gross revenue includes tax, and, therefore, the billable rate must be adjusted to include the effect of applying the tax rate to the other taxes.

The WUTC will review each of these filings and has the authority to set final rates that may vary from Cascade's requests, either higher or lower, depending on the results of its investigation.

If the WUTC approves all proposals, the total increase for a residential customer using 54 therms per month will be .05 percent or \$0.03 more per month, bringing the total average monthly Cascade bill from \$51.69 to \$51.72.

The combined proposed rate changes for residential, commercial, and industrial customers are:
