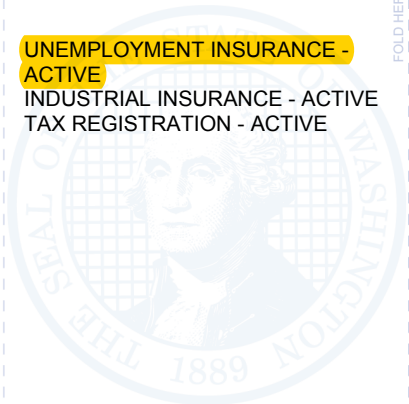

**1. Watch the mail for your official Rate Notice, welcome letter, PAC Code, and required workplace posters.**

**2. Get ready to report your workers' hours and pay premiums *online* every quarter.**

- **Create your [My L&I account](#)**

You will need your Account ID (listed above), UBI number, and PAC code to set up your online account. Employers typically complete their quarterly reports within 10 minutes because we auto-calculate premiums due. If you need help setting up your online access call 360-902-4817.

- **Add these quarterly filing due dates to your calendar:** January 31, April 30, July 31, and October 31.

- **If an *outside* accountant, payroll, or leasing company will be filing and paying for you,** complete and send back an [Authorization to Access on Behalf of Employer Form](#) so we can allow them online access.

- **No worker hours to report?** You are required to file a report every quarter. If we do not receive your 'Zero Hour' report by the deadline, our system will automatically send you an estimated premium and charge you a late fee penalty and any applicable
