Dear Valued Commercial Customer,

This is to notify you of a proposed rate change for commercial services in the Rabanco, Ltd. dba Sea-Tac Disposal Company, Republic Services of Kent, areas of King County. Should the Washington Utilities and Transportation Commission (Commission) approve our request, customers will experience an overall rate increase throughout all classes of service.

As you may know, it has been a year since our last general rate case. In that time Sea-Tac Disposal has experienced increases in costs that are key to delivering our services including labor, fuel and maintenance costs. In addition, the company continues to invest in new assets to ensure it can deliver the safest, most efficient service possible. **If approved, the proposed rates will become effective May 1, 2023.**
