00002 1 PROCEEDINGS 2 JUDGE HENDRICKS: We're here this afternoon for a prehearing conference in Docket Number UT-013019. 3 4 This matter arises from the filing by Focal 5 Communications Corporation of Washington of a Petition 6 for Enforcement of Section 252(i). Today is April 23rd, 7 2001, and we're appearing in Room 108 in the Commission 8 headquarters building in Olympia, Washington. I'm Tre 9 Hendricks, and I'm the Administrative Law Judge assigned 10 by the Commission to this stage of the proceeding. Also 11 present are Jing Roth from Commission Staff, Beth 12 Redfield from the Commission's Policy Staff, and Larry 13 Berg, an Administrative Law Judge, and they're serving 14 as advisors today. I will start by taking appearances from all 15 16 parties starting with Mr. Kopta. Please state for the 17 record your name, who you represent, your address, 18 telephone, and fax numbers, and an E-mail if you use 19 one. 20 MR. KOPTA: Thank you, Your Honor. This is 21 Gregory J. Kopta of the law firm Davis Wright Tremaine, 22 LLP, on behalf of Focal Communications Corporation of 23 Washington. 00003 1 E-mail, gregkopta, all one word lower case, 2 gregkopta@dwt.com. 3 JUDGE HENDRICKS: Thank you, Mr. Kopta. 4 And, Ms. Newman. 5 MS. NEWMAN: Yes, good afternoon. My name is 6 Kimberly Newman of the law firm of Hunton and Williams 7 on behalf of Verizon. The address for Hunton and 8 Williams is 1900 "K" Street Northwest, Suite 1200, 9 Washington D.C. 20006. My telephone number is (202) 10 778-2225. My fax number is (202) 778-2201. And my 11 E-mail address is all lower case knewman@hunton.com. 12 JUDGE HENDRICKS: Thank you, Ms. Newman. 13 Are there any preliminary matters to come 14 before the Commission at this time? Before reviewing -- I should also ask, are 15 16 there any protests or petitions to intervene at this 17 time or petitions to intervene? 18 Before reviewing the issues presented and the 19 motion to dismiss, I want to find out if the parties are 20 engaged in any settlement discussions. I was looking at 21 the news wire on Friday and saw that Verizon and Focal 22 have entered into interconnection agreements in seven 23 other states, and those appear, at least just from the 24 reading of the news wire, that they address issues that 25 are in dispute in this case. Can the parties address

1 that? 2 MR. KOPTA: This is Greg Kopta. I'm not 3 aware of any discussions that are going on specific to 4 Washington. There have been some informal discussions 5 in terms of general alternatives for perhaps resolving 6 this matter between the parties, but nothing that I 7 would state is anything as formal as what you were just 8 referring to, Your Honor. So at this point, my 9 understanding from talking with representatives of my 10 client on Friday of last week was that there is no 11 resolution in Washington and that we need to proceed 12 with this particular proceeding at this point. 13 JUDGE HENDRICKS: Ms. Newman. 14 MS. NEWMAN: I agree with Mr. Kopta's 15 representations that there have not been any formal discussions of settlement between him and myself. I 16 17 hasten to add, however, that Verizon is always open to 18 trying to resolve this matter. Indeed, we have 19 requested, as you know, Your Honor, a mediation, and we 20 do believe a resolution is possible, and we would 21 welcome formal discussions with Focal on this point. JUDGE HENDRICKS: Well, I don't know if that 22 23 answers the question well, but why don't we proceed. 24 I would like to ask in this matter from 25 reading the proceeding, from reading the pleadings,

00005 1 there don't appear to be any factual issues that are in dispute. If there are, I'm not sure of their import or 2 their complexity. Are there issues other than pure 3 4 legal issues that are in dispute? 5 MR. KOPTA: This is Greg Kopta. I'm not 6 aware of any factual issues that are in dispute. My 7 understanding based on reviewing the response that 8 Verizon filed is that there are issues of law and 9 perhaps policy that have been raised, but none of fact 10 that I'm aware of. 11 JUDGE HENDRICKS: Ms. Newman. 12 MS. NEWMAN: Well, I would take it from 13 counsel for Focal's representations that they didn't 14 disagree with any facts as we represented in our response, but we obviously do have disagreements about 15 16 the application of the law. 17 JUDGE HENDRICKS: In light of that now, and 18 also to Ms. Newman, your petition for -- your motion to 19 dismiss is couched in terms of a motion to dismiss only 20 the request for expedited review; is that right? 21 MS. NEWMAN: That is correct, Your Honor. 22 JUDGE HENDRICKS: Okay. And then, of course, 23 you have answered as well. Now in light of the fact 24 that there are only legal issues in dispute, those I 25 think might be resolved within a fairly short time frame 00006 1 regardless of whether or not the Commission would grant 2 expedited review under WAC 480-09-530, and so it would seem to be prudent just to move on to resolving the 3 4 issues of Focal's petition, and what I foresee is 5 resolving that through written briefs on a schedule to 6 be determined by the Commission. Do the parties agree 7 that that's a good way to proceed? 8 MR. KOPTA: This is Greg Kopta, we would 9 agree that that's an appropriate way to proceed. 10 MS. NEWMAN: Your Honor, Verizon agrees as 11 well. 12 JUDGE HENDRICKS: Okay. And why don't we go 13 off the record for just a minute to discuss timing for 14 these briefings. (Discussion off the record.) 15 16 JUDGE HENDRICKS: After discussing scheduling 17 for the briefings, the parties will file simultaneous 18 briefings, opening briefs on May 10th and reply briefs 19 on May 24th. The Commission will enter a Prehearing 20 Conference Order in which it will outline the issues 21 which the Commission would like to have the parties to 22 address and the schedule for the briefings. Any 23 objection to the provisions of the order must be filed 24 within ten days after the entry of the order. 25 Absent such objections, the Prehearing

1 Conference Order will control further proceedings in 2 this matter subject to Commission review. The order 3 will also remind parties that the Commission encourages 4 the settlement process under 480-09-466 or other means 5 of alternative dispute resolution which are covered in 6 480-09-465 in the Washington Administrative Code. The 7 Commission should be advised of any progress made in 8 that regard. The Prehearing Conference Order will 9 include the schedule, as I said, as well as a list of 10 issues the parties must address. 11 With regard to the filings themselves, the 12 parties must file the original plus eight copies for 13 internal distribution at the Commission. Please 14 remember that all filings must be made through the 15 Commission's secretary either by mail to the secretary at the Washington Utilities and Transportation 16 17 Commission, P.O. Box 47250, 1300 South Evergreen Park 18 Drive Southwest, Olympia, Washington 98504-7250. That 19 information will be provided in the Prehearing 20 Conference Order as well. We will require the filings 21 of substance, the briefs, include an electronic copy on 22 three by five inch diskette in PDF format, Microsoft 23 Word, or Word Perfect 5.0 or later format. Service on

24 all parties must be simultaneous with filing. And 25 ordinarily, the Commission doesn't except these filings
