On behalf of three of the parties in the above-captioned general rate proceeding, this is to request, pursuant to WAC 480-07-385 (2) (a) and due to the present COVID-19 pandemic which is directly impacting availability of resources, documents, communications and parties, an extension to the schedule in Prehearing Conference Order 02, to include the following adjusted dates:

EVENT	CURRENT DATE	PROPOSED DATE
Staff and Intervenors' Response Testimony and Exhibits	April 22, 2020	May 13, 2020
Rebuttal and Cross Answering Testimony	May 26, 2020	July 8, 2020

All of the remaining scheduled deadline dates under the agreement would be continued six weeks into the future, including the suspension date which the parties agree to extend from October 23, 2020 to December 4, 2020.

The parties also request that Prehearing Conference Order 02 be amended to shorten the deadline for responding to data requests to five business days following the May 13, 2020 deadline for response testimony.

Party representatives are available to discuss the impact of the proposal with the administrative law judge and these proposed extended schedule dates for which we seek your approval and are unaware of when the hearing date could be scheduled approximately six weeks out based on the Commissioners' schedule/calendar availability over the summer. We understand that Intervenor PMSA is not in full agreement with this request and we would expect them to respond separately.
