## **DECLARATION**

I am Executive Director of the Washington Refuse and Recycling Association (WRRA), a non-profit trade association, which represents the vast majority of solid waste collection companies in the State of Washington. Points Recycling and Refuse is a member of WRRA, and in view of that status, and WRRA's interest in any litigation involving a "G" Certificate, I have followed the events in Point Roberts, which have led to these various legal actions, closely.

At the request of James K. Sells, WRRA's General Counsel and Point's attorney in these matters, Judge Rendahl allowed me to be present at the mediation session which took place in Bellingham on February 25, 2009. Thus, I was present, but in accordance with Judge Rendahl's wishes, did not take part in the settlement discussions, although during breaks I was present when Mr. Sells and Mr. Wilkowski discussed the proceedings.

I can state unequivocally that I have never spoken to, met, or in any manner whatever, had any contact with anyone from the Point Roberts newspaper, regarding this, or any other matter. I signed the Confidentiality Agreement and have strictly adhered to its terms. I am aware that Judge Rendahl circulated a written summary of what was at least a tentative agreement amongst the participants, but I did not receive a copy and am unaware of its contents.
