Dear BM Logistics LLC:

On August 3, 2018, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation permit would be canceled unless you submitted acceptable proof of insurance by September 7, 2018. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, the Commission has CANCELED your provisional permit and dismissed your application for permanent household goods authority. You must immediately CEASE all operations associated with this permit. If you advertise or operate as a household goods mover without a valid permit, the commission may take enforcement action against you.

You have the right to a hearing. If you believe the Commission should not have canceled your certificate, you may ask the Commission to schedule a hearing before an administrative law judge.
