  - Recyclable material is segregated.
- 0016 If you are segregating recyclable materials please identify where you take it for disposal or processing.
  - Kitsap County Recycling Collection Center either at Olympic view transfer station or Dickey Road located in Silverdale, WA.
- Old Please provide weight tickets for the recycling material from the time you began collecting this material to the present.

Weight tickets are not given for dumping of recycling materials at these facilities.

  - CDL is not required for the vehicle being used by Superior.

  - Mr. Stein has a CDL, and retains his DOT# and is aware of complying with FMCSA drug and alcohol education/ ongoing testing.

    - Mr. Stein currently holds a CDL, however, it is not required for the activities of solid waste collection for the size and weight of the vehicle in use.

Mr. Stein has a valid Washington state driver's license, retains the DOT#, is aware of the drug and alcohol education/testing. Mr. Stein is also aware of carrying \$750,000 combined single limit of public liability and property damage insurance-form E.

c. Please identify each certification or license, if any, that Mr. Stein holds relevant to maintaining Superior's compliance with the referenced regulations.

Mr. Stein has a valid Washington driver's license STEINDJ192JQ. DOT#3202197. Superior is in compliance with all FMCSA regulations.

    - Mr. Stein attended (ATS) All Training Services in Port Orchard, WA for truck driver training school. Part of the training covered hours of service extensively. Mr. Stein also drove for Swift Long Haul for 8 months running logs both digital and paper. Mr. Stein has had to deal with multiple time zones for delivery of freight with an interstate CDL. He also drove side dump, belly dump, pneumatic sand tanker, water tanker, dump and pup, all class A CMV vehicles in North Dakota oil fields. All North Dakota CMV jobs ran on 14-hour log books.
  - b. Please describe the driver's hours of service requirements expected to apply to Superior when operating under its requested certificate.
    - Mr. Stein does not have any current plans to hire any employees as drivers.
  - c. Please identify each certification or license, if any, that Mr. Stein holds relevant to maintaining Superior's compliance with the referenced regulations.
    - Mr. Stein received driver awards at Swift for on time and correct logs both electronic and paper logs. Mr. Stein has held a CDL in good standing since 2010 with no lapses.

    - As part of his training at (ATS) All Training Services Truck driving school in Port Orchard, WA, Mr. Stein trained extensively for pre and post trip inspections. He has taken his knowledge into the real world and put it into practice where he has identified issues early. He is willing to, if warranted, place his vehicle out of service until issues can be fixed by a licensed mechanic.
  - b. Please describe the inspection, repair, and maintenance requirements expected to apply to Superior when operating under its requested certificate.
    - Pre and post trip inspections of a CMV is a vital part of a safe road worthy vehicle. To include but not be limited to inspecting for cuts, cracks, crimps, chafing, among other things. All lights and signaling devices to be checked for proper operation. This would also include all fluids checks and replacement pertaining to the proper operation of the CMV and checking for obstructions of windshield and or mirrors. Additionally, ensuring windshield defrost and mirror heat are operational.

Mr. Stein holds a CDL license.
