Dear Ms. Maxwell:

On December 12, 2022, the Washington Utilities and Transportation Commission (Commission) entered Order 10/04 in Dockets UE-220053, UG-220054, and UE-210854 (*consolidated*). Order 10/04, among other things, rejected the initial tariff proposals by Avista and required Avista to make a compliance filing by December 14, 2022, consistent with the Order. On December 19, 2022, the Commission approved the Company's compliance filing.

In Order 10/04, Avista was required to remove Colstrip costs from base rates and include those costs in a separate tariff (Schedule 99). On January 17, 2023, Avista Corporation d/b/a/ Avista Utilities (Avista or Company) notified Commission staff (Staff), that there was an incorrect formula in the original compliance filing that resulted in incorrect rates for Schedules 13/23, Schedule 21, and Schedule 31. The formula error inadvertently removed the Colstrip costs from the billing rates instead of base rates. The effect was an overstated base rate for these schedules.

Upon acknowledgement, the Company will immediately cancel and rebill all impacted customers to ensure they are accurately billed the correct rate.

Staff has reviewed the Company's supplemental compliance filing. Staff believes that the revised tariff revisions comply with Order 10/04, entered December 12, 2022.
