This filing is in compliance with Order No. 03 in Docket Nos. UE-051828 and UE-051966 (Consolidated) ("Order No. 03") which recommended that the Commission approve and adopt the Settlement Agreement executed by all parties to those Dockets. RCW 80.01.060(3) provides that Order No. 03 become the final order on the day following expiration of the time established by the Commission for filing a petition for administrative review, unless, within that time, a party petitions for administrative review or the Commission notifies parties that it will review the initial order on its own motion. The Company is not aware of any petition for administrative review or pending Commission review of Order No. 03. WAC 480-07-825(2) establishes the period for petition for administrative review at twenty (20) days, therefore Order No. 03 became a final order on July 27, 2006.

Order No. 03, at paragraph 57 requires that PSE file tariff sheets that are necessary and sufficient to effectuate the terms of Order No. 03 within 21 days after the effective date of a final order. This filing is that required filing and the tariff sheets are identical to those tariff sheets attached to the Settlement Agreement approved and adopted by Order No. 03 with the exception that issue dates, effective dates and advice number has been added along with the notation "By Authority of the Washington Utilities and Transportation Commission in Docket Nos. UE-051828 & UE-051966".

The tariff sheets described herein reflect issue dates of July 28, 2006, and effective dates of August 1, 2006. Notice of the proposed tariff change, as required by law and the Commission's rules and regulations, is being given to the public immediately prior to or coincident with the date of this transmittal letter, through web, telephone and mail access in accordance with WAC 480-100-193(1). This filing changes terms or conditions without restricting access to electric service. Accordingly, pursuant to WAC 480-100-195(3), the Company will be providing notice to customers as provided in WAC 480-100-193(1).
