1 I.INTRODUCTION AND PURPOSE OF TESTIMONY

2 Q. PLEASE STATE YOUR NAME, POSITION, EMPLOYER, BUSINESS ADDRESS,

3 AND QUALIFICATIONS.

4 A. My name is Margaret S. Bumgarner. I am employed by Qwest Corporation ("Qwest",

5 formerly U S WEST Communications, Inc.) as a Director in the Policy and Law

6 organization. My business address is Room 2803, 1600 7th Avenue, Seattle,

7 Washington, 98191. I submitted direct testimony in this docket on August 7, 2000.

8 Q. WHAT IS THE PURPOSE OF YOUR TESTIMONY?

9 The purpose of my supplemental testimony is to provide the Commission with specific
10 information regarding Checklist Item No. 11, Number Portability, as requested in the
11 Supplemental Interpretive and Policy Statement issued in Docket No. UT-970300 and
12 adopted by Order dated March 21, 2000.

II.COMMISSION QUESTIONS

14 DOES YOUR DIRECT TESTIMONY DATED AUGUST 7, 2000 PROVIDE ANSWERS TO

15 THE QUESTIONS THE COMMISSION ASKED IN THE SUPPLEMENTAL AND

16 INTERPRETIVE POLICY STATEMENT?

17 A. Yes. In Exhibit A, Section V, Subsections A and L, the Commission asked ten
18 generic questions and seven specific questions regarding the number portability
19 requirements of Section 271(c)(2)(B)(xi) of the Act. My direct testimony addressed

12 A. Qwest has ported telephone numbers to twenty-one CLECs. Confidential Exhibit
13 MSB-32C is a list of CLECs with ported telephone numbers.

14 Q. GENERIC QUESTION 4: DESCRIBE HOW THE QUALITY AND RELIABILITY OF

15 CHECKLIST ITEMS PROVIDED TO COMPETITORS BY QWEST ARE

18 A. Both the Act and the FCC define number portability as the ability of customers to

1 retain, at the same location, existing telephone numbers when switching from one 2 service provider to another.¹ Thus, there is no comparison to Qwest providing number 3 portability to itself. The Regional Oversight Committee ("ROC") has developed 4 performance indicators for number portability which are described in my direct 5 testimony and Exhibit MSB-26.

SPECIFIC QUESTION 2: TO WHICH CLECS IS QWEST PROVIDING INTERIM 6 Q. NUMBER PORTABILITY, AND UNDER WHAT TERMS, CONDITIONS AND RATES? 7

8 A. Qwest has ported telephone numbers to 5 service providers using interim number 9 portability ("INP"). Confidential Exhibit MSB-32C is a list of service providers that still 10 have numbers ported using INP. There is virtually zero demand for INP at this point 11 due to the significant deployment of LNP by Qwest in Washington. As stated in my 12 direct testimony, the FCC requires that when LNP has been deployed in an area, then 13 interim methods can no longer be used.² On October 2, 2000, LNP deployment will 14 be completed in all Qwest end office switches in Washington making LNP available 15 to 100 percent of Qwest's access lines in Washington. The terms, conditions, and 16 rates for INP are described in Section 10.1 and Exhibit A of the SGAT.
