CERTIFICATE OF IMPLEMENTATION

1. My name is John A. Wimsatt. I am the Senior Vice President within Verizon's Domestic Telecom line of business responsible for Verizon's broadband product management and development, including Verizon's Digital Subscriber Line ("DSL") services. I am authorized to make this Certification on behalf of Verizon with regard to the above-referenced matter.

2. In accordance with the condition set forth in the *Verizon/MCI Merger Order*, I hereby certify that, to the best of my knowledge, information, and belief, as of the date of this Certification, Verizon offers "stand-alone" Asymmetrical DSL ("ADSL") within the local service areas of Verizon's incumbent local telephone companies. Stand-alone ADSL means ADSL service on ADSL-equipped lines without requiring customers to also purchase circuit-switched voice-grade telephone service. This service is available both for existing Verizon voice and ADSL customers who wish to port their voice service to a provider of Voice over Internet Protocol ("VoIP") service or to another facilities-based provider such as cable or wireless, and for new customers who wish to subscribe only to Verizon's ADSL and not to its voice service.

3. I declare under penalty of perjury that the foregoing is true and correct.
